Candidate Registration / Certification Charges

Supplementary Charges

General Invoicing

Upon receipt of the Application Form, a non-refundable invoice will be raised and payment will be required via the Go Cardless Direct Debit system. Candidate Registration Deadlines

Candidates must be registered with iPET Network within 10 working days of the start of the course or before any assessments are completed (whichever is earlier).

Candidate Registration Dates

If a Candidate fails to complete within the qualification registration duration, the following package costs will be charged for re-registration unless the Candidate is eligible for an extension, please see policy for further information.

External Quality Assurance Remote Rolling Sampling

Rolling remote External Quality Assurance sampling is completed monthly by the External Quality Assurance team and is included in the registration fee. This means Candidates do not have to be 100% completed prior to a scheduled monitoring or re-approval External Quality Assurance audit. This strategy ensures that Candidates are not waiting excessive time for certificates. From IQA certificate request, the EQA can take up to 8 weeks to approve. When remote rolling sampling is completed, evidence will be recorded on the most recent External Quality Assurance report and confirmed that the certificate claims have been approved.

External Quality Assurance Audits

External Quality Assurance (EQA) activities are included in each Candidate registration. All approved Training Providers will receive an annual quality assurance audit per year as standard. As part of our Quality Assurance Strategy, formal monitoring and re-approval audits are completed every 6 months from a Training Provider's original approval date. This activity normally takes 2 hours. Auditing of Training Provider branches will be included in these audits.

Should the Training Provider want or be required by iPET Network to receive additional audits outside the planned quality assurance audit per year, iPET Network will charge for each audit. iPET Network will always confirm the time needed and additional fees to complete the review before the commencement of the audit.
